

## Contract Agreement Form

### CONTRACT FOR THE PURCHASE AND DELIVERY OF 7-SEATER, MULTI-PURPOSE VEHICLE (MPV) FOR OFFICE OF THE MAYOR

THIS AGREEMENT made this 10<sup>th</sup> day of November 2023, in the Province of Bataan, between:

The **MUNICIPALITY OF ORION**, with office address at San Vicente, Orion, Bataan, represented herein by Municipal Mayor **ANTONIO L. RAYMUNDO JR.**; and herein referred to as the "ENTITY"

-and-

**TOYOTA BATAAN, INC.**, a private entity duly organized and existing under the laws of the Philippines, with business address at Tuyó, Balanga City authorized and represented herein by its General Manager **MICHAEL ANGELO T. TAN**, of legal age, married and a residence Quezon City, hereinafter referred to as the "SUPPLIER"

WHEREAS, the Entity is desirous that the Supplier execute *the delivery of 7-Seater, Multi-Purpose Vehicle (MPV) for Office of the Mayor* (hereinafter called "the Goods") and the Entity has accepted the Bid for *Two Million Three Hundred Forty-Seven Thousand Pesos (Php 2,347,000.00)* by the Supplier for the execution and completion of such works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:

- (a) General and Special Conditions of Contract;
- (b) Specifications;
- (c) Invitation to Apply for Eligibility and to Bid;
- (d) Instructions to Bidders;
- (e) Bid Data Sheet;
- (f) Addenda and/or Supplemental/Bid Bulletins, if any;
- (g) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security;
- (j) Credit line issued by a licensed bank, if any;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Contractor/Supplier as hereinafter mentioned, the Contractor/Supplier hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor/Supplier in consideration of the execution and completion of the Works/Goods and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

5. In order to assure the manufacturing defects shall be corrected by the supplier, a warranty security shall be required from the contract awardee from the minimum of 3 months.

6. The obligation for the warranty shall be covered by the either retention money in the amount equivalent 1% of every progress payment or special bank guarantee equivalent to at least 1% of the total contract price.

#### **Liquidated Damages**

7. Where the supplier refuses or fails to satisfactory complete the delivery with-in the specified contract time, plus any time extension duly granted and it hereby in default under the contract, the supplier shall pay the procuring entity for liquidated damages, and not by way of penalty, an amount as provided in the conditions of the contract equal to at least on tenth (1/10) of one (1) percent of the cost of the undelivered products for every day of delay.

#### **Payment**

8. Partial Payment is allowed based on the value of goods which the supplier delivered on a partial or staggered delivery.

#### **Completion covered:/Contract Completion**


9. The goods shall be completed within Thirty (30) calendar days after receiving of notice to proceed.


