### **BAC RESOLUTION NO. 121 series of 2023**

#### **BAC Resolution Recommending Negotiated Procurement (Emergency Case) for Hotel / Room Accommodation and Event Place for CDRA and LSP Write shop / Training**

**WHEREAS**, the local government units have the primary responsibility on shelter planning and addressing the housing needs of their constituents. This was embodied in the Local Government Code of 1991 (Republic Act 7160) and the Urban Development and Housing Act of 1992 (Republic Act 7179).

**WHEREAS**, in the above-mentioned responsibilities, the people who are responsible for this must have a proper training or workshop to enable them for effective implementation.

**WHEREAS**, On the above-mentioned write shop / training, participants need a proper place for training as well as facilitator or resource person who is an expert for this field to properly teach the participant. The resource person is from Department of Human Settlements and Urban Development (DHSUD).

**WHEREAS**, the availability of resource persons to conduct training is on November 28 – December 1, 2023 only.

**WHEREAS**, upon checking on nearby possible event place, only Subic Bay Venezia Hotel is available or has available room and function room for the above-mention dates.

**WHEREAS**, Item 3.2 of the foregoing Circular, citing Section 53.2 of the 2016 revised IRR and Item V(D)(2a) of Annex "H" of the same IRR, on Negotiated Procurement (Emergency Cases) modality may be resorted to in the following instances:

- (a) in case of imminent danger to life or property during a state of calamity;
- (b) when time is of the essence arising from natural or man-made calamities; or
- (c) other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities.

**NOW, THEREFORE**, We the members of the Bids and Awards Committee, hereby RESOLVE, as it is hereby RESOLVED

- a) To recommend the procurement of Hotel / Room Accommodation and Event Place for CDRA and LSP Write shop / Training to Subic Bay Venezia Hotel under Negotiated Procurement (Emergency Purchase).

- b) To recommend for approval by the Municipal Mayor of the Municipality of Orion, Bataan foregoing findings.


