BAC Resolution Declaring Direct Contracting for the Replacement of Cable of CCTV Cameras

WHEREAS, the Municipality of Orion, purchase and install 68 units CCTV Cameras last January 2020 through public bidding.

WHEREAS, the above-mention item where deliver and installed by the winning bidder Lightnet Connect Systems Corporation.

WHEREAS, some of CCTV cable were found to be burnt and they need to be replaced immediately to function properly.

WHEREAS, Sec 50 of the Revised Implementing Rules and Regulation of RA 9184 provides that **Direct Contracting** or Single Source Procurement is a method of procurement does not require elaborate bidding documents. The supplier is simply asked to submit a price quotation or a pro-forma invoice together with a condition of sale. The offer maybe accepted immediately or after some negotiation. **Direct Contracting** may be resorted to by concerned procurement entities under any of the following conditions;

- a. Procurement of Good of proprietary nature which can be obtain only from the proprietary source, i.e., when patent, trade secret, and copywrites prohibit other form manufacturing the same item.
- b. When the procurement of critical components from specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract; or
- c. Those sold by an exclusive dealer or manufacturer which does not have sub-dealers selling at lower prices and for which no suitable substitute can be obtained at more advantageous to GoP.

WHEREAS, to maintain the best quality of the CCTV, the replacement of cable of affected CCTV must be done by Lightnet Connect Systems Corporation, an authorized Distributor and Service Center of the said CCTV.

WHEREAS, upon review of the foregoing details, the BAC found that the above condition for Direct Contracting is satisfied.

NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a.) To recommend the Replacement of Cable of CCTV Cameras to Lightnet Connect Systems Corporation through direct contracting.

b.) To recommend for approval by the Municipal Mayor of the Municipality of Orion, Bataan foregoing findings
