CONTRACT AGREEMENT

THIS AGREEMENT, made this 15th day of *November* 2023 between *Municipality of Orion with office address at San Vicente*, *Orion Bataan* represented by its *Municipal Mayor Antonio L. Raymundo Jr* (herein called the "Entity"; and *Supreme Builders Construction and Trading with office address Poblacion*, *Balanga City represented by its owner/manager Hubert B. Pizarro* (hereinafter called the "Contractor").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - a. Philippine Bidding Documents (PBDs);
 - i. Drawings/Plans;
 - ii. Specifications;
 - iii. Bill of Quantities;
 - iv. General and Special Conditions of Contract;
 - v. Supplemental or Bid Bulletins, if any;
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Nine Hundred Ninety-Four Thousand Nine Hundred Ninety-Seven Pesos and 6/100 (Php 994,997.06) or such other sums as may be ascertained, Supreme Builders Construction and Trading agrees to construct the Renewable Energy-Based Electrification at Brgy Capunitan, Orion, Bataan in accordance with his/her/its Bid.
