BAC Resolution Declaring Single Calculated and Responsive Bid

WHEREAS, the Municipality of Orion, Bataan advertised the Invitation to Apply for Eligibility and to Bid of the project Labor and Materials for the Rehabilitation of Drainage for the Road Leading to Orion Memorial Park at Brgy Balagtas, Orion, Bataan with an ABC of Four Hundred Eighty-Six Thousand Pesos (Php 486,000.00) in PhilGEPS and a conspicuous place in the premises of the municipality of Orion, Bataan continuously from October 12 – 25, 2023.

- b.) To recommend for approval by the Municipal Mayor of the Municipality of Orion, Bataan foregoing findings


