#### **BAC Resolution Recommending Negotiated Procurement (Emergency Case) for Food for RHU 2023 Program Implementation Review**

**WHEREAS**, On December 16-17, 2023, Rural Health Unit of Orion will conduct 2023 Program Implementation Review.

**WHEREAS**, on the above-mentioned event, food will be needed for the participant as well venue to accommodate all the participant. And due to late receiving of purchase request, the remaining days to process the request was not enough.

**WHEREAS**, Item 3.2 of the foregoing Circular, citing Section 53.2 of the 2016 revised IRR and Item V(D)(2a) of Annex "H" of the same IRR, on Negotiated Procurement (Emergency Cases) modality may be resorted to in the following instances:

- (a) in case of imminent danger to life or property during a state of calamity;
- (b) when time is of the essence arising from natural or man-made calamities; or
- (c) other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities.

**WHEREAS**, after checking on supplier and event venue within the municipality, only Lynnette's Kitchen Catering Services can accommodate the requirements within the said schedule dates. And because of holiday season where event venue now are in high demand, the food supplier (Lynnette's Kitchen Catering Services) is also responsible for finding a venue for the above-mention event.
