

## Contract Agreement Form

### Purchase and Delivery of Fish and Vegetables for Supplementary Feeding of Child Enrolled in Child Development Center

THIS AGREEMENT made this 19<sup>th</sup> day of January 2024, in the Province of Bataan, between:

The **MUNICIPALITY OF ORION**, with office address at San Vicente, Orion, Bataan, represented herein by Municipal Mayor **ANTONIO L. RAYMUNDO JR.**; and herein referred to as the "ENTITY"

-and-

**ERLY'S FRUITS AND VEGETABLE STORE<sub>2</sub>**, a private entity duly organized and existing under the laws of the Philippines, with business address at Gen Lim, Orion, Bataan authorized and represented herein by its Owner/Manager **ANGELO P. BANSIL** of legal age and a residence of Gen Lim, Orion, Bataan hereinafter referred to as the "SUPPLIER"

WHEREAS, the Entity is desirous that the Supplier execute *the delivery of Fish and Vegetables for Supplementary Feeding of Child Enrolled in Child Development Center* (hereinafter called "the Goods") and the Entity has accepted the Bid for the amount **One Million Two Hundred Fourteen Thousand Five Hundred Thirty-Five Pesos Pesos (Php 1,214,535.00)** by the Supplier for the execution and completion of such works and the remedying of any defects therein.

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
  - (a) Contractor / Suppliers Quotation
3. In consideration of the payments to be made by the Entity to the Contractor/Supplier as hereinafter mentioned, the Contractor/Supplier hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects. Payment can be made as per delivery accompanied by Billing / Sales Invoice and Delivery Receipt.
4. The Entity hereby covenants to pay the Contractor/Supplier in consideration of the execution and completion of the Works/Goods and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

**Liquidated Damages**

7. Where the supplier refuses or fails to satisfactory complete the delivery with-in the specified contract time, plus any time extension duly granted and it hereby in default under the contract, the supplier shall pay the procuring entity for liquidated damages, and not by way of penalty, an amount as provided in the conditions of the contract equal to at least on tenth (1/10) of one (1) percent of the cost of the undelivered products for every day of delay.

**Completion covered:/Contract Completion**


8. The goods shall be completed within One Hundred Eighty (180) calendar days after receiving of notice to proceed.
