#### **BAC Resolution Recommending Negotiated Procurement (Emergency Case) for Purchase and Delivery of Grocery for Supplementary Feeding of Child Enrolled in Child Development Center**

**WHEREAS**, Starting January 22, 2024, the Orion MSWD Will start their feeding program for Child Enrolled in Child Development Center.

**WHEREAS**, the proposed menu from the MSWD needs Groceries to complete their feeding program for 6 months.

**WHEREAS**, the time required to purchase the above-mention item was too short and need to look for illegible supplier that can accommodate the needed supplies immediately.

**WHEREAS**, Item 3.2 of the foregoing Circular, citing Section 53.2 of the 2016 revised IRR and Item V(D)(2a) of Annex "H" of the same IRR, on Negotiated Procurement (Emergency Cases) modality may be resorted to in the following instances:

- (a) in case of imminent danger to life or property during a state of calamity;
- (b) when time is of the essence arising from natural or man-made calamities; or
- (c) other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities.
