BAC Resolution Declaring Single Calculated and Responsive Bid

WHEREAS, the Municipality of Orion, Bataan advertised the Invitation to Apply for Eligibility and to Bid of the project <u>Labor and Materials for the Rehabilitation of Government Building to Become BP344 (Accessibility Law) Compliant MDRRMO Building, Trading Post & Evacuation Center at Sto.
