### **BAC RESOLUTION NO. 021 series of 2024**

#### **BAC Resolution Declaring Change of Procurement Mode from Public Bidding to Negotiated Procurement under Emergency Cases for the Project Purchase of Food and Snacks for Provincial Athletic Meet 2024**

**WHEREAS**, the Municipality of Orion, Bataan advertised the Invitation to Apply for Eligibility and to Bid of the project of Purchase of Food and Snacks for Provincial Athletic Meet 2024 with an ABC of Two Hundred Eighty-Three Thousand Nine Hundred Twenty Pesos (Php 283,920.00) in PhilGEPS and a conspicuous place in the premises of the municipality of Orion, Bataan continuously from January 24 – February 7, 2024.

**WHEREAS**, on February 7, 2024, the scheduled deadline and opening of bid for the above-mention project was declared failure of bidding due to no bids are received.

**WHERE AS**, under the section 53.1 of the 2016 revised IRR of R.A. No. 9184 may be adopted under the following;

53.1 Two **Failed Bidding** Where there has been failure of competitive bidding or limited source bidding for the second time as provided by section 35 of the act and this IRR.

**WHEREAS**, the above item to bid is need to be settled before the event date which is February 21-23, 2024 to avoid any problem or delays. And the remaining days for bidding process was not enough.

**WHEREAS**, Item 3.2 of the foregoing Circular, citing Section 53.2 of the 2016 revised IRR and Item V(D)(2a) of Annex "H" of the same IRR, on Negotiated Procurement (Emergency Cases) modality may be resorted to in the following instances:

- (a) in case of imminent danger to life or property during a state of calamity;
- (b) when time is of the essence arising from natural or man-made calamities; or
- (c) other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities.

**WHEREAS**, after checking on local market, only Lynnette Catering Services, can deliver the item on time and can accommodate all the foods needed for the whole event.

**NOW, THEREFORE**, We the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:


- a.) To chance the procurement process from public bidding to Negotiated Procurement under Emergency Cases even though the bidding failed only once.


- b.) To recommend the procurement of Food and Snacks for the Provincial Athletic Meet 2024 under Negotiated Procurement under Emergency Cases.
- c.) To recommend the approval by the acting municipal mayor of the Municipality of Orion Bataan foregoing findings.


