

BAC Resolution Recommending Negotiated Procurement (Emergency Case) for Purchase of Uniform of Provincial Athletic Meet 2024 (Elementary Education) Participants

WHEREAS, the DepEd Orion District will participate on upcoming provincial sports event (Provincial Athletic Meet 2024) that will be held on February 21-23, 2024.

WHEREAS, the above-mention event, the participants need a uniform for both Elementary and Secondary Level, it's just that we received the purchase request late so that it couldn't be process into public bidding.

WHEREAS, the quantity of uniform needed for both Elementary and Secondary lever is too much for one supplier to accommodate before the event date.

WHEREAS, Item 3.2 of the foregoing Circular, citing Section 53.2 of the 2016 revised IRR and Item V(D)(2a) of Annex "H" of the same IRR, on Negotiated Procurement (Emergency Cases) modality may be resorted to in the following instances:

- (a) in case of imminent danger to life or property during a state of calamity;
- (b) when time is of the essence arising from natural or man-made calamities; or
- other causes where immediate action is necessary to prevent damage to or loss of life or property, or to restore vital public services, infrastructure facilities and other public utilities.

WHEREAS, Gorillas Sportswear Trading is one of the most experienced in doing these types of uniform and has eligibility requirement.
