WHEREAS, upon careful examination on the bid proposal of the bidder with Lowest Calculated Bid, its bid has been found to be responsive;


NOW, THEREFORE, We the members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED


